## **INTERNATIONAL PROFESSIONAL EXCHANGE PROGRAM in Oujda - MARCH 13<sup>th</sup> to 26<sup>th</sup> 2020**

The goal of the Council of International Fellowship (CIF) is to promote professional, cultural and educational exchange for professionals working in the field of Social Work and Human Services.

The program combines theoretical and practical information about the social and cultural environment of Morocco. Cross-cultural exchange is an important part of the program as participants come from different countries, thus providing opportunities for professional development, sharing and learning as well as broadening professional and personal horizons.

### **Eligibility for participation:**

Candidates should be professionally qualified with a minimum of two years of professional experience and should be able to communicate with both languages: **French & English**.

### **PROGRAM STAGES:**

#### **Theoretical program (Friday- Sunday) 13-14-15 March**

The three days theoretical program takes place in Oujda and it is an orientation and overview about Morocco, its political, educational and social welfare system. Special emphasis is placed upon social work in Oujda and Moroccan way of life. The program is a combination of seminars, and participants are involved in discussions to enhance their understanding of Moroccan culture.

**Fieldwork experience & host family living** (from Monday to Saturday, 16-21 March): An individual one-week placement based on the participant's field of social work. During this part of the program, the participants will go to the fieldwork agency and live in host family.

**Discovering the area / tourist trip:** Saturday-Sunday-Monday, 21-23 March

**Agencies and institutions visits:** Monday-Tuesday, 23-24 March

**Evaluation & farewell party:** Wednesday, 25 March

**DEPARTURE:** Thursday, 26 March

### **Relevant information:**

Participants must have their own health insurance before arriving in the country. It must cover medical treatment, hospital stays and medication. The CIF Morocco cannot cover health expenses and does not take any responsibility in this regard.

### **Application:**

The applications need to go through the CIF National Branch or Contact Person in your country, using the international application form in English or the one in French.

Accepted candidates pay their own expenses from their country to Oujda location program and return. Participants need money for their own personal spending and for all expenses before during and after the program.

**Number of participants: 3-4**

**Deadline for applications: DECEMBER 15<sup>th</sup> 2019.**

**Expenses Conditions:** Participants contribution is 350 euro to cover the financial expenses during the program
